The trustees of the Trust are the Promoters / Promoter Group members. As per the SEBI order the annual affirmation on compliance of the order was sent to the exchanges on 05.04.2021 and also being confirmed here. 2. The Beneficial Ownership has been reported as the Promoters exercise 100% "Control" on Nav Srijit Telangana Pvt Ltd. who in turn has majority control in Waterbase Limited. Only the direct ownership of shares percentage has been reported in the Beneficial Declaration considering that the Trust is a Discretionary Trust with identified Beneficiaries.
