PRESS RELEASE

The Waterbase Limited - Update on Operations

Chennai, December 21, 2015: The Waterbase Limited, pioneer in the aquaculture industry in India and a leading manufacturer of shrimp feed has provided an update on its Operations in Tamil Nadu and Andhra Pradesh after the sustained heavy rainfall which led to severe flooding causing disruptions to its business activities.

The heavy rains resulted in flooding of its factory located at Ananthapuram Village in Nellore District. As a result, the Company's operations have been disrupted and the factory has been shut down since November 19, 2015. Through the crisis, the Company has ensured the safety of its employees and their families.

The heavy rains and floods have adversely impacted the shrimp farming in many areas of Andhra Pradesh and Tamil Nadu. Several shrimp farms have been inundated with flood water. As a result, sales of shrimp feed and processing of shrimps were affected.

The progress of Company's Hatchery project is hampered due to rains and could get delayed.

The company will be able to assess the damages caused by the floods, upon assessment done by the insurance company. Efforts are on to restart the operations at its Nellore facility at the earliest.

Outlook for the Quarter ending December 31, 2015

The recent rains and the resultant flooding is expected to have a material impact on the revenues and operating margins of the Company in the seasonally weak third Quarter. However, this incident will result in a one-time cost incurred towards recovery and restoration of business operations to normalcy.
